SHIP-IN-SEMEN AGREEMENT

THIS AGREEMENT is made and entered into this day and month written below between Char-O-Lot Ranch, Myakka City, Florida

and _____ (“Mare Owner”). These parties agree as follows:

1. Mare Owner agrees to breed the mare (“Mare”) _____

 to _____ with SHIPPED-IN Semen during the 2024 breeding season and to pay the Chute Fee together with other
 Name of Stallion reimbursable expenses.
2. The Chute Fee for cooled semen shall be \$400.00. The chute fee for frozen semen is \$500.00. **The Chute Fee must be paid in full prior to the shipment of semen. A Visa or MasterCard number is required for Federal Express freight to return Equitainers or frozen shippers.**
3. The Chute Fee shall include the following:
 - a. All communications regarding the ordering and receiving of the semen.
 - b. All transportation arrangements either via Fed Ex or counter to counter with courier arrangements as well.
 - c. Paperwork required to return Equitainers or Shippers in a timely manner.
4. Any additional charges will be billed monthly. Bills are to be paid in full prior to mare leaving premises unless otherwise agreed in advance by both parties. Unpaid balances may be billed to your credit card. Additional charges include but are not limited to: Airport Courier Fee and applicable airline freight charges.
5. Char-O-Lot Ranch shall attempt with reasonable diligence to settle mare; if however, for any reason the mare does not settle, Mare Owner will hold Char-O-Lot ranch and manager harmless.
6. The breeding season for shipped semen begins February 1st and closes June 15th at which time all breeding will be discontinued. If the mare does not settle in the 2024 breeding season, Char-O-Lot Ranch will honor a re-breed on the mare originally booked for a re-breed fee of \$350.00, for the following year only (2025 season).
7. **IF MARE LEAVES PREMISES PRIOR TO 21 DAY ULTRASOUND, RE-BREEDS WILL NOT BE HONORED.**
8. Board shall be as follows:

9. Foaling Charge to have mare foal on Breeder’s premises is \$500.00 which includes use of Foalert System. .
10. **ALL BOARD AND EXPENSES ON MARE AND/OR FOAL SHALL BE PAID MONTHLY AND ARE DUE UPON RECEIPT OF INVOICE.**
11. Breeder will exercise judgement consistent with recognized standards in care and supervision of mare and/or foal. Breeder assumes responsibility for arranging veterinarian and farrier services as necessary. All veterinary expenses and all farrier expenses will be paid by Mare Owner.
12. The mare shall be in a healthy and sound breeding condition, free from infectious, contagious, or transmissible disease. A current negative Coggins Test, photostat copy of registration papers (both sides), must accompany mare. A photostat copy of completed Stallion Service contract from shipping stallion along with collection date information and semen ordering notification requirements.
13. Char-O-Lot Ranch or representatives shall not be liable for injury, sickness, or death of the mare and/or her foal, regardless of how it may occur. This agreement constitutes the entire agreement between the parties; any amendment to or modifications of the terms of this agreement must be in writing.
 Should it be necessary for Stallion Owner to employ an attorney to enforce any of the terms of this agreement, including collection of money owed, Mare Owner shall reasonable attorney’s fees, costs of suits, and other expenses reasonably related to enforcing this agreement.
