## STALLION SERVICE CONTRACT

### Shipped Cooled Semen

THIS Stallion Service Agreement is made and entered into this day and month written below between, JOHN LOVELACE("Stallion Owner") CHAR-O-LOT RANCH, Myakka City, Florida (agent) and \_\_\_\_\_("Mare Owner"). These parties agree as follows:

1. Mare Owner agrees to breed the mare ("Mare") \_\_\_\_\_

to **SECRET HEIR** standing at CHAR-O-LOT RANCH, MYAKKA CITY, FLORIDA for the 2017 season and to pay the Stallion Service Fee together with other reimbursable expenses set forth herein.
2. The Stallion Service Fee shall be \$950.00. **A Visa or Mastercard account number is required for Federal Express freight, insurance and deposit on Equitainer.**
3. The Stallion Service Fee shall include the following:
  - a. Breeding Fee
  - b. Collection Fee for the first shipment, provided it is made on a regular breeding day (Monday, Wednesday, Friday ) and the Stallion Owner is notified prior to **10:00 a.m.** Eastern Time on the day semen is shipped. **All shipping charges, both to receive semen shipment and to return Equitainer are the responsibility of the mare owner. CR shall not be responsible for the cost arising from shipments lost, damaged or delayed in transit, or condition of cooled semen upon delivery. We have no control of the shipment after it leaves our custody.**
4. Subsequent Shipments. For each shipment following the **first shipment**, the Mare Owner shall be responsible for the following:
  - a. \$175.00 Semen Collection Fee for next day Federal Express service.
  - b. If same day service is necessary, a \$175.00 Semen Collection Fee plus an additional \$300.00 airport courier fee will be assessed.
  - c. All additional charges and/or unpaid balances shall be automatically billed to your credit card unless otherwise agreed upon in advance by both parties. Charges may include but are not limited to collection fees, off day charges, airport courier fees, and airline freight charges.
5. Any shipments requested on **Off Breeding Days**, including the first shipment, will be charged an additional fee of \$175.00.
6. Hamilton-Thorne Equitainer Requirements. CHAR-O-LOT RANCH will require a Visa or Mastercard from each Mare Owner as security for the Equitainer. **Each Equitainer received must be returned to CHAR-O-LOT RANCH within 72 hours of receipt.** In the event the Equitainer is not returned within 72 hours, the Mare Owner will be assessed a non-refundable charge of \$25 per day until the Equitainer is returned. The maximum charge will not exceed \$300.00. Char-O-Lot Ranch will use disposable shipping containers weather permitting.
7. Mare Owner shall attempt with reasonable diligence to settle mare; if however, for any reason the mare does not settle, Mare Owner will hold Stallion Owner and manager harmless.
8. The breeding season for shipped semen begins February 1st and closes June 15th at which time all shipments will be discontinued.
9. If the mare does not settle in 2017, the Stallion Owner will honor the Stallion Service Fee on the mare originally booked (unless otherwise mutually agreed in writing between Mare Owner and Stallion Owner) for the following year only (2018 season). In 2018, the Mare Owner has two options:
  - a. Mare can be brought to Char-O-Lot Ranch, Myakka City, Florida for service, provided the Mare Owner is responsible for all additional charges other than the service fee, **OR**
  - b. Mare Owner may again ship semen, however, an additional \$350.00 chute fee will be charged.
10. Stallion Owner guarantees live foal from the breeding contracted for herein. Live foal is defined as a foal that stands and nurses without assistance. Should the Mare prove not to be in foal in the year bred or lose her foal, or should the foal not stand and nurse without assistance. Mare Owner shall notify Stallion Owner in writing within one week of foaling date (or the date the Mare is proved not to be in foal or loses her foal); such notice shall be accompanied by a statement from a licensed veterinarian verifying that the foal is not "live" as defined above or has been lost as stated above. Under the foregoing circumstances and upon receipt of the specified notice, it is agreed:
  - a. Stallion Owner shall give to Mare Owner (1) one season to the Stallion, per the terms of Paragraph 9, the following year only and to the same Mare originally booked.
  - b. If Mare Owner fails to deliver the Mare for rebreeding the following year, then any and all fees paid shall not be refundable; the right to rebreed is thereby canceled and Stallion Owner is released from any further obligation.
11. The parties agree that should the above named stallion die or become unfit for service, the mare owner shall be entitled to substitute the above stallion with another s owned by the stallion owner.
12. This contract shall not be transferable by Mare Owner. A Breeders Certificate will be issued with the Mare Owner notifies Char-O-Lot Ranch of the birth of the foal and only after payment of all bills due on the Mare have been received. This agreement constitutes the entire agreement between the parties; any amendment to or modification of the terms of this agreement must be in writing.
13. Should it be necessary for the Stallion Owner to employ an attorney to enforce any of the terms of this agreement, including collection of money owed, Mare Owner shall pay all reasonable attorney's fees, costs of suits, and other expenses reasonably related to enforcing this agreement.
